Line 9: Citizenship – applicant **MUST** answer. *This is frequently overlooked.*

COMMON ERRORS/THINGS TO REMEMBER:

- **Include mailing address**, if different than physical (**Line 2 must be completed**) address
- **Line 6 – Political Parties** are **DEM, REP, or LIB (not Independent)** – if left blank or DTS (decline to state), applicant cannot vote in PRIMARY ELECTION and should check box to right “If you choose NO PARTY.”
